Reference this Department's Office Memorandum of even number dated 11th November, 2010 informing Ministries/Departments etc. not to deal with three firms namely/s Amira Foods India Ltd., 54, Prakriti Marg, Sultanpur Farms, Mehrauli, New-Delhi, M/s Shivnath Rai Harnarain India Limited., Shri Lal Mahal House, B-5, Bhagwan Das Nagar, New-Delhi-26 and M/s Emmsons International Ltd., 101, South Delhi House, 12 Zamrudpur Community Centre, Kailash Colony, New-Delhi-48

2. It is clarified that the ban imposed on these firms would also be applicable to all existing sister or subsidiary firms/companies as well as newly floated or acquired commercial entities in which any owner(s) of these debarred firms has or would have any direct or indirect beneficial interest.

3. Ministries/Departments are requested to send suitable advisories to all organizations including public sector undertakings under their administrative control.




