**Sub:- Revision of pay scales of technical posts consequent upon
implementation of VI Central Pay Commission - regarding.**

Sir,

Reference is invited to entry No. 16 and 17 of Section I Part A of the first schedule to the CCS (RP) Rules, 2008 which reads as under:-

As per earlier instructions posts carrying scale of pay with a maximum of not less than Rs.13500 were classified as Group 'A'. However, as per DoPT Notification No.S.O.946(E) dated 9.4.2009 posts carrying grade pay of Rs.5400 are classified in Group 'A' as well as Group 'B'. Accordingly, the matter whether technical employees in Grade T-6 are to be placed in PB-2 or PB-3 was under consideration of the Council in consultation with the Deptt. of Expenditure, Ministry of Finance. In the meantime the technical employees of the Council in T-6 grade were placed in PB-2 vide Circular of even number dated 18th May, 2009, till a final decision was taken.
