Areas of consensus:

- (d) Practical training in pre-identified or otherwise selected field site as per existing norms of both the parties.

Obligations/Responsibilities of the Parties:

- (a) Both sides will maintain ongoing communication and circulate essential information in a timely manner.
- (b) Each party acts on its own behalf in all relations with a third party. Neither party will be responsible for any outside commitments of the other party.

This MoU shall become effective on the date it is signed by the parties and shall be valid for three years extendable up to five years. The period of validity of this MoU may be extended by mutual written consent up to five years. Both parties shall review the status of the MoU at the end of each three/five year period to determine any modification, whenever necessary. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least six months in advance from the effective date of termination.

No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties and their authorized representatives. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/executed, unless otherwise agreed to.
