

INTRODUCTION

Productivity means producing the “right products and services” efficiently along with better utilization of capacity. Productivity may be enhanced through more competent management or better allocation of existing resources resulting in higher efficiency or better utilization of scarce resources or higher productivity.

Maintaining higher levels of productivity growth is the panacea for maintaining competitive edge. Competitiveness can be defined and measured at different levels-national, sectoral, regional or at firm level. Globalization has further enlarged the dimensions of analysis and contributed to the proliferation of definitions and indicators of competitiveness. Competitiveness is a dynamic concept as factors affecting competitiveness change over time and context.

NPC training programme has been designed to provide an understanding of Productivity & Competitiveness Measurement and also for imparting the skill and knowledge on theory and measurement of Productivity and Competitiveness at Organizational, Sectoral and National levels for achieving organizational excellence.
