**Sub: Clarification on cut-off date for revision of Pension of Pre-
2006 pensioners of scientific category- Regarding
Sirs,**

The Council vide its endorsement No.21-9/2013-CDN dated 4th August, 2015 has endorsed the Ministry of Personnel, PG& Pensions, Department of Pension & Pensioners Welfare (DoP&PW) Government of India OM No.38/37/08-P&PW (A) dated 30th July, 2015 regarding revised cut-off date for the revision of pension of pre-2006 pensioners as **1.1.2006 instead of 24.09.2012.**

Some of the Institutes of ICAR have sought clarifications that whether the Council's endorsement dated 4th August, 2015 is applicable for revising the pension of pre-2006 pensioners of scientific category. The issue was considered in consultation with Finance Division, ICAR and it has been decided that a clarification in the matter may be issued in light of the DoP&PW OM dated 30.07.2015.


Therefore, it is hereby clarified that the Council's endorsement No.21-9/2013-CDN dated 4th August, 2015 is equally applicable in respect of pre-2006 pensioners of scientific category. Accordingly, the pension/family pension of pre-2006 pensioners of scientific category may be revised with effect from 1.1.2006 instead of 24.9.2012.

All the other stipulations as given in the letters No.1-4/2009-Per.IV dated 30.1.2014 and 14.08.2014 shall remain the same.


