- ii) The next return as on 31.3.2015 under the Lokpal and Lokayuktas Act, 2013 should be filed on or before the 15.4.2016.
- iii) The annual return as on 31.3.2016 under the Lokpal and Lokayuktas Act, 2013 should be filed on or before the 31.7.2016.
- iv) The annual return for subsequent years as on 31st March, every year should be filed on or before the 31st July, of that year.

Accordingly, all employees are requested to adhere to the above instructions and file their returns to their respective establishments on the above mentioned dates. The above O.M. has been uploaded on the ICAR web-site www.icar.org.in and e-office for information and strict compliance.
