Department of Personnel and Training, Ministry of Personnel, Public Grievances and Pensions, Government of India, New Delhi vide their D.O.No. 407/12/2014-AVD-IV(B) Part.I dated 30th July, 2015 has forwarded a copy of the Govt. of India Notification dated 03rd July, 2015 amending the public servants (furnishing of information and annual returns of assets and liabilities and limits for exemption of assets on filing returns) Amendment Rules, 2015.

In view of the aforesaid notification, the timeline for filing of returns/declarations, specific to different years, by public servants under the Lokpal and Lokayuktas Act, 2013, are as follows:-

- the first return (as on 1st August, 2014) [as was initially required to be filed by 15th September, 2014] can now be filed by 15th October, 2015.
- the annual return (as on 31st March, 2015) [as was initially required to be filed by 31st July, 2015], can now be filed by 15th October, 2015.
- the subsequent annual returns (as on 31st March of each year) are required to be filed by 31st July of that year.

Accordingly, all employees are requested to adhere to the above instructions and file their returns to their respective establishments on the above mentioned dates. The D.O. letter alongwith the notification has been uploaded on the ICAR web-site www.icar.org.in and e-office for information and compliance.
