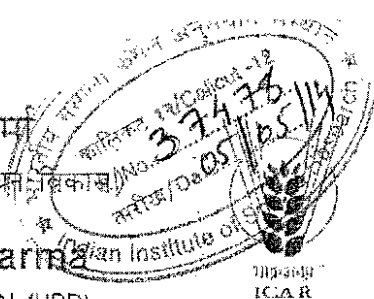


OFFICE MEMORANDUM

Sub: - Revised guidelines for Senior Research Fellows and Research Associates working in the ICAR schemes - reg.

In order to clarify the rates of the TA/DA on tour admissible to RAs/SRFs engaged in various schemes/projects of ICAR schemes/Institutes for settlement of their bills, the Governing Body of ICAR in its 230th Meeting held on 12th March, 2014 has approved the revision in provision No. 10 of the existing Guidelines for Senior Research Fellows and Research Associates working in the ICAR schemes with immediate effect. Accordingly, para 10 of the Guidelines for the ICAR National Professorial Chairs stands revised as follows:

"If the exigencies of the work demands and if there is sufficient budget provision under the scheme, the SRFs/RAs may be deputed on tour by the PI concerned. During the tour, the TA/DA entitlements for the SRFs/RAs should be regulated as per the entitlements for regular employees in the grade pay of Rs. 4,200 to 4,800."

The Revised Guidelines have been circulated and uploaded on ICAR website.
