Subject: Revised Score-card for direct selection to senior scientific positions in ICAR -reg.

Sir,

As you are aware, a committee was constituted under the Chairmanship of Dr. R.S. Paroda, former Director General, ICAR and Secretary, (DARE) to undertake a comprehensive review of the ARS. The terms of reference to the Committee inter-alia included review of the existing score-card for direct selection of applicants to senior scientific positions in the ICAR.

Dr. Paroda Committee had recommended a revised score-card for direct selection to various senior scientific positions in the ICAR in order to bring in more objectivity and transparency in selection process. The recommendations of the Committee were considered by the "Committee on ARS" under the Chairmanship of Director General, ICAR. The Committee on ARS after detailed discussions, rationalized the score-card/weightages for various parameters recommended by Dr. Paroda Committee for screening and selection of applicants by the ASRB. The recommendations of the Committee on ARS have been approved by the Hon'ble AM & President, ICAR.



A statement showing the score-card for various parameters for screening of applicants as approved by the Hon'ble AM is annexed (Annexure-I). The criteria for selection of applicants shall be as under:-

- i) The first ten ranking candidates for each post subject to a minimum of 50% and 60% marks in the screening as per score-card shall be eligible for interview for selection to non-RMPs and RMPs respectively.
- ii) The final selection shall be made by giving weightage to scorecard marks and interview marks in the manner indicated in the statement as in Annexure-II.


