- (i) The Department of Personnel & Training has put on its website the details of the vacancies at the level of DS / Director / Joint Secretary occurring during the course of the year. The details of these vacancies which are likely to arise during the year 2005 have been displayed on the website.
- (ii) The Department of Personnel & Training issues an annual circular to all the State Governments / cadre controlling authorities for forwarding the names of officers for placement under the Central Staffing Scheme (CSS). The annual circular has also been put on its website. This Department after taking into account the vacancies and job requirements of various Departments/Ministries, ACR

gradings and vigilance status of officers offered for placement under the Central Staffing Scheme retains their names in the offer list. The offer list is also displayed on the official website.


(iii) The Department of Personnel and Training has also put on its website the Executive Record Sheets (ER sheets) of all the IAS officers containing the details of their qualifications /trainings /postings, etc. These ER sheets are continuously updated and are also used in the computerized programme for preparation of panels.

(iv) The Department of Personnel and Training in collaboration with the NIC has also created a new website i.e. IntraIAS wherein an IAS officer can personally check the status of the submission of his ACRs for the last ten years.

(v) Various circulars containing important instructions / guidelines issued by the Department of Personnel and Training and also vacancy circulars issued for posts not covered under Central Staffing Scheme are also displayed on the website.
