<b>Essential qualification</b>	BSc in Horticulture/Agriculture/Life Science or 3 years Diploma in Horticulture / Agriculture
<b>Job Profile</b>	Assist scientists in carrying out planned research activities, record observations, perform data entry and statistical analysis, undertake extraction of essential oils and oleoresins, and carry out any tasks assigned by the Head or concerned scientist as required.
<b>Duration</b>	Initial engagement will be for one year which is extendable up to three years (01 year at a time) subject to requirement of the services of the YP in the organization and satisfactory performance of the candidate.
<b>TA/DA</b>	TA/DA will be admissible to YP I for undertaking domestic tour for official work
<b>Age limit</b>	Minimum 21 and maximum 45 years as on date of written test/Interview. Candidates born on or in between 12.05.1981 and 12.05.2005 may apply. (Age relaxation is applicable for SC/ST/OBC/Physically Challenged/ Ex-Serviceman candidates as per Govt. of India Rules)
